MERRITT PARKWAY (Rt. 15) - EXIT 42 (Weston Rd)

Coming from New York - Turn Left on Rt. 57 New Haven - Turn Right on Rt. 57

Don't continue on Rt 57 - Take a left at fork in road (Weston Road) Go straight until you can't go any further, then turn left (Cross Highway). Go 1 mile to first stop sign (North Ave) then turn right. Go a little more than a mile until you can't go any further and turn left (Long Lots Road). The Hunt Club is on the right about 1 mile - Look for the Polo Field.

I-95 FROM NEW HAVEN (Southbound)

Get off at Exit 19. At the bottom of the ramp you will come to a stop sign (you will see The Box Car Cafe on the right) Go straight to the traffic light, take a right onto the Post Road (Route 1). At the third traffic light take a right onto Bulkley Avenue (An AT&T Wireless Building will be on your right at the light). Bulkley Avenue is a long winding road at the end of it is a stop sign, take a left (you will see a large polo field on your left) onto Long Lots Road. Take your first left into our driveway.

I-95 FROM NEW YORK (Northbound)

Exit 18 - Sherwood Island. At the end of the ramp turn left. Go approximately 1 mile to Post Road (Rt. 1). You will see the Bertucci Restaurant on left. Turn left - then take a quick right. You will be on Long Lots Road right in back of the restaurant. Go straight for about 1½ miles. The Hunt Club is on the right. If you start passing our Polo Field you have gone too far.

(the "Federation") and the local rules of _____ (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status. RULES AND REGULATIONS

1. Every class offered herein which is covered by the rules and specifications of the current USEF, CHJA, NEHC & FW-PHA Rule Books will be conducted and judged in accordance therewith.
2. **Eventing Competitions at the Preliminary Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions; 8) Opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner Novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.**
3. Hunter fences to include brush, gate, wall, in and out, aiken, natural rails. Jumper fences to include brush, coop, wall, planks, panels, liverpools, natural obstacles and rails.
4. Fairfield County Hunt Club, Ox Ridge and Horse Show Management shall not be liable whatsoever for any injury or damage to any person or property of any spectator, visitor, attendant or any other persons, or animals by reason of any event occurring during the show, and it shall be a condition of entry that each exhibitor hold the same as well as their agents and/or employees harmless for any accident or loss which may occur by fire or otherwise.
5. The right is reserved to cancel, combine or divide any classes if entries warrant. In addition, the right is reserved to refuse any entry before the start of the competition without being liable for compensation.
6. Course diagrams will be posted at least one hour prior to each class.
Management reserves the right to restrict the area of the courtesy circle by a **MANDATORY LINE**. The same will be indicated on course diagrams and a corresponding barrier will be erected in the ring.
7. Riders to be properly attired for all classes. Protective headgear is required at all times when mounted. Riders may wear a protective vest either body protecting or inflatable, specifically designed for use in equestrian sport in any division or class without penalty from the judge. The Federation recommends that the vest pass or surpass the current ASTM standard F1937 or be certified by the Safety Equipment Institute. For Eventing, inflatable vests are permitted only when worn over a body protecting vest.
8. Measurements available by appointment with Fairfield Equine Associates.
9. Absolutely **NO DOGS** or other pets allowed on the grounds unless leashed and under control.
10. Should any question or dispute arise not provided for in these rules, the same shall be referred to show management whose decision shall be final.
11. It is the responsibility of the exhibitor to have **CURRENT MEMBERSHIPS** for any and all classes, which require the same.
12. **POST ENTRIES** accepted at \$25.
13. No charge to exhibitors if management cancels the show prior to competition.
14. Ring sizes and footing: Emerson Burr ring 125 x 225, sand. Upper Sand Ring 100 x 200 sand. Indoor Ring

- 100 x 200 all weather footing (show ring), Indoor warm up areas: 90 x 250 all weather footing
15. Stabling: Limited availability in permanent stalls with stall doors. 10x 10 Stalls, Clay base with rubber mats.
16. There will be a \$50.00 fee for any returned check.
17. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
- The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
18. Every class offered herein which is recognized by CHJA will be conducted and judged in accordance with the current CHJA Rules. To show in CHJA Medal classes, riders **MUST** be members. In order to compete for CHJA annual year-end awards, the owner of the horse or pony must be a member of the CHJA and the horse or pony must be registered with the CHJA. Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides.

A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined

Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are

exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes

for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used

regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7)

assistant handlers in Dressage Sport Horse Breeding classes**Reminder:**

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for
