- Installation & dismantling of your items in the rented space as well as securing flaps daily is the responsibility of the vendor.
- Opening flaps daily will be the responsibility of the Hunt Club. Closing the flaps is responsibility of vendor.
- The Fairfield County Hunt Club does not provide tables or chairs. Vendor space has back wall, but no side walls.
- Night watch will be provided by the Hunt Club only during the evening hours.
- Tent space will be provided by the Fairfield County Hunt Club and your location will be assigned by the Hunt Club.
- Electricity is to be arranged in advance of the show so please mark off if you will require electricity in the space below.
- A certificate of insurance naming the Fairfield County Hunt Club as additional insured will be required and must accompany payment, along with application, to be considered. Check-in is Monday June 17<sup>th</sup>, 9 a.m. until 2 p.m. setup must be complete by 4 p.m.
- First Come, First Served basis. Contracts must be received by May 1, 2019 to be included in the Official Show Program.
- Upon acceptance of Contract, Vendor information will be placed on the June Show website.
- Vendor operation days are Tuesday through Saturday.
