## SHORT STIRRUP EQUITATION

Shown at the walk, trot, and canter both ways of the ring. Diagonals and leads considered. Riders will be asked to jump a course of at least four, but not more than eight, obstacles. All jumps must be cross-rails, not to exceed 18" in height. May trot or canter over obstacles. CHJA Points.

## RULES & REGULATIONS

1. EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULEBOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. Unless otherwise specified, all hunter classes to be judged on performance and soundness. Every class offered herein which is recognized by the CHJA/NEHC will be conducted and judged in accordance with the current CHJA/NEHC Rules. To show in CHJA & NEHC Medal classes, riders MUST be members. In order to compete for CHJA/NEHC annual year-end awards, the owner of the horse or pony must be a member of the CHJA/NEHC and the horse or pony must be registered with the CHJA/NEHC. A copy of the CHJA/NEHC Rule Books, class specifications, Medal class specifications, and membership applications are available at the show secretary's office and at [www.chja.net](http://www.chja.net) & [www.nehc.info](http://www.nehc.info).
2. Every animal entered for competition shall be under the control of show management; but Fairfield County Hunt Club, CT Hunter Jumper Association & BHC Management will in no way be responsible for any loss, accident or damage that may occur by fire or otherwise and it shall be a condition of entry that each exhibitor, spectator, trainer and attendant hold Fairfield County Hunt Club, CT Hunter Jumper Assoc. & BHC Management, and its members, employees and agents harmless for any loss or damage that may occur to any persons, animals or property at the show.
3. Management reserves the right to cancel, combine or divide any classes if in its opinion the entries so warrant, while maintaining minimum USEF requirements to fill a class.
4. Course diagrams will be posted at least one hour prior to each class. Management reserves the right to restrict the area of the courtesy circle by a MANDATORY LINE. The same will be indicated on course diagrams and a corresponding barrier will be erected in the ring.
5. Jumpers times calculated at 360 yds/minute. For other than first place the time taken to complete the first round will decide between horses with equal faults. Jump orders will be established at the in gate. Classics will have a posted order of go.
6. Prize Money will be applied against the exhibitor's account. Any remaining balance will be mailed to the owner on record within 30 days of the completion of the show. No prize money will be issued without proper Social Security or Tax ID Numbers. 1099s will be issued for prize money over \$600.
7. Sharps containers MUST be used. Location available at the secretary's desk & stabling areas. \$100 fine for improper disposal of sharps.
8. Open checks, USEF/USHJA Membership Cards, and Measurement Cards must be presented & verified by the show secretary prior to issuing any numbers. Responsibility lies with the exhibitor to possess all needed membership & measurement cards. Any fines issue to the horse show will be the responsibility of the exhibitor.
9. We request that you LEAVE DOGS HOME. Any dogs on the property MUST be leashed and under control. \$100 fine for loose or unruly dogs.
10. Office Fee of \$50 will be charged to each entry.
11. **Entries & Stalls close August 3rd. Stalls must be pre-paid at \$250 per stall. \$20 Night Watch will be automatically applied unless specified otherwise by the exhibitor. Post entries will be taken as time permits at \$50 per entry. Horses not stabled on the show grounds will be assessed a \$20 ship-in fee per entry. 12. Measurements will be completed at 10am each show day behind Fairfield Barn 2.
13. Hay, shavings & grain available to order through Danbury Agway. 203-743-7500.
14. Returned checks or unpaid entries are subject to a \$100 fee plus any bank service charges.
15. All classes must be declared prior to the start of the class. Bandit entries will be charged a \$15 post entry fee per class for all non-entered classes. Classes not scratched prior to the start of the class will be the responsibility of the exhibitor.
16. **All exhibitors MUST present proof of Vaccinations per GR845.**
17. Prize Money Paid for Hunter Classes: 30%, 22%, 18%, 15%, 8%, 7% unless otherwise noted.
18. Prize Money Paid for Jumper Classes: 30%, 20%, 15%, 13%, 12%, 10%, unless otherwise noted.
19. Horses are permitted to arrive on the property on Wednesday August 16, 2017. After 10am.

### MOTORIZED VEHICLE STATEMENT

In accordance with GR1301.7:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

### USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.
