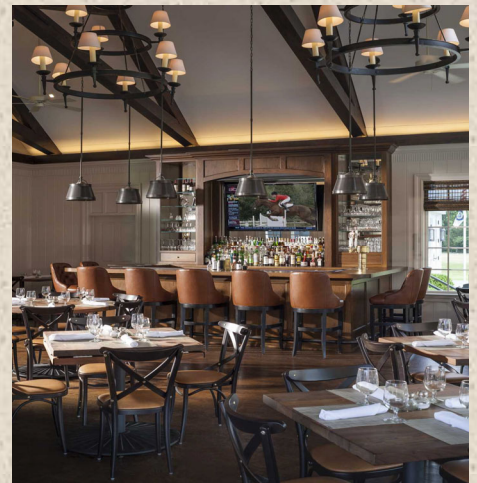

The Fairfield County Hunt Club offers year round clubhouse dining. The Clubhouse facilities underwent a major renovation which was completed in December 2014. The Club's Main Dining room is a beautiful facility with its adjacent verandah which offers additional seating with an all season enclosure. The Polo Room offers formal dining for adults only with a beautiful view of the Club's Show Ring and Polo Field, and the Grill Room offers a casual Country Club atmosphere with indoor and outdoor seating.

A la carte and casual dining options are offered throughout the year as well as Special Events. The Culinary team at the Hunt Club is full of exceptional talent.

Our goal is to provide a gracious dining experience for the Hunt Club membership through excellence of food, professional service and great atmosphere. Our Club is a place where members will be proud to come and entertain their family and guests.

### Equestrian Activities

The Fairfield County Hunt Club offers riding lessons for beginner, intermediate and advanced riders, either privately or in a small group setting. The Club has successfully met the needs of members, from those who wish to compete at the highest levels to those who wish to enjoy the pleasure of recreational riding. Our highly skilled instructors teach all levels of equitation, hunters, and jumpers.

Lessons are taught on your privately owned horse or one of our Club animals.  
The Club maintains 10 - 15 quality horses and ponies for our lesson program.

FCHC can accommodate up to 120 horses. Each horse is treated as a distinct individual. The professional grooms, trainers, and stables manager all monitor each animal closely and create personalized feeding, veterinary and training programs.

The Fairfield County Hunt Club is home to a number of nationally recognized equestrian events. FCHC hosts monthly rated shows, which are recognized by the United States Equestrian Federation (USEF), New England Horsemen's Council (NEHC), and the Connecticut Hunter Jumper Association (CHJA).

On a smaller scale, the Summer Schooling Show Series allows riders who are beginning to show, as well as those who want to fine tune their skills, to get valuable showing experience in a less formal atmosphere.

# Swimming & Pool Activities

The Hunt Club has a six lane, 25 yard heated swimming pool, and a baby pool. The pool is open Memorial Day weekend through early September. Swimming, diving and lifesaving lessons may be arranged with the Pool Director. The club has a swim team that participates in meets at both home and away at other area clubs. It is the hub of summer activity. Poolside BBQ dinners are held weekly throughout the summer and the area hosts various other special events during the season. The area is equipped with beautifully renovated locker rooms with showers, private dressing area and digital lockers for member use. A seasonal snack bar is opened when the pool is open and offers a wide variety of items such as salads, paninis, grilled items snacks and more.

# Children's Summer Program

The Fairfield County Hunt Club operates a state licensed day camp which is exclusive to members. Our program receives top ratings from the State of Connecticut each year during the annual routine inspection. Each season campers ages 3 -12 enjoy an action packed program. Initiation Fee: \$24,000.00

Annual Dues: \$9,658.25

Clubhouse Minimum Spending: \$150.00 per month

Capital Assessment: \$160.00 per month

#### **Full B**

Eligibility: Candidates over 52, whose youngest child is 18 years old or older

Privileges: Access to all facilities and services offered

Application Requirements: Application completed and signed by proposer and seconder. Letters are required from proposer, seconder and 2 additional Full or Full B Members demonstrating how they know the candidate, relationship to candidate etc.

Initiation Fee: \$16,000.00

Annual Dues: \$5,959.15

Clubhouse Minimum Spending: \$150.00 per month

Capital Assessment: \$160.00 per month

Clubhouse Minimum Spending: \$150.00 per month-,billed monthly or quarterly

Capital Assessment: \$64.00 per month

### **House & Hut Senior**

Eligibility: Current Members 80 years old and older who have been Members for 20 years or more.

Privileges: Clubhouse and Paddle Tennis

Application Requirements: None- available through transfer only

Initiation Fee: None

Annual Dues: \$1,931.65

Clubhouse Minimum Spending: \$150.00 per month, billed monthly or quarterly

Capital Assessment: \$32.00 per month

### **Winter House & Hut**

Eligibility: Candidates all ages

Privileges: Clubhouse and Paddle Tennis. Member privileges October 1<sup>st</sup> through March 31<sup>st</sup> annually.

Application Requirements: Application completed and signed by Proposer. Letters are required from proposer, seconder and two additional members.

Initiation Fee: \$3,500.00

Annual Dues: \$1,575.00

Clubhouse Minimum Spending: \$150.00 per month-,billed monthly or quarterly

Capital Assessment: \$64.00 per month

### Member Class Outline

#### **Non-Resident**

**Eligibility:** A current Member in good standing who does not live, have a place of business or spends more than 30 days within 75 miles of the Clubhouse.

**Privileges:** Use of all facilities limited to 21 days per calendar year of use of the Club.

**Application Requirements:** Letter of request to transfer submitted to Membership Committee for Board approval.

**Initiation Fee:** None- shall pay a \$500.00 reinstatement fee, when again assuming full membership.

**Annual Dues:** \$965.85

**Clubhouse Minimum Spending:** None

**Capital Assessment:** \$16.00 per month, billed annually

### **Riding**

Eligibility: Non-Member candidates.

Privileges: Boarding of horses, lessons, unlimited use of the equine facilities, and the Snack Bar in the summer. This membership does not extend to any other member of the family.

Application Requirements: Completed application and recommendation of the Riding Activities Committee. Annual membership, which must be renewed by Board approval, annually.

Initiation Fee: None

Annual Dues: \$2,657.00

Clubhouse Minimum Spending: Does not apply, no Clubhouse privileges

Riding Minimum: Two lessons, per month

Capital Assessment: None

### **College Riding**

Eligibility: Non-member candidates 25 years old or younger, who are enrolled in a college or university.

Privileges: Boarding of horses, lessons, unlimited use of the equine facilities from September through May. This membership does not extend to any other member of the family.

Application Requirements: Completed application and recommendation of the Riding Activities Committee. Membership must be renewed by Board approval, annually.

Initiation Fee: None

Dues: \$1,993.00

Clubhouse Minimum Spending: Does not apply, no Clubhouse privileges

Riding Minimum: Two lessons, per month<sup>SEP</sup>

Capital Assessment: None
